Exigencia aplicable a los vehículos entrantes durante la prestación de los servicios de transporte de pasajeros Beneficiarios del Programa Renueva Tu Micro

El vehículo entrante:

- a) No podrá participar nuevamente del Programa, sino sólo como vehículo saliente, en los casos que corresponda.
- b) No podrá cambiar de tipo de servicio ni de región, por un período de, a lo menos, 36 meses contados desde la fecha de inicio de la segunda etapa de postulación, conforme lo establezcan los respectivos Gobiernos Regionales al inicio de la convocatoria, mientras la propiedad del vehículo entrante corresponda al postulante.
- c) No podrá realizar en los días hábiles del período señalado en la letra precedente, servicios especiales regulados en el Decreto Supremo N° 237, de 1992, del Ministerio de Transportes y Telecomunicaciones. Para estos efectos, se entenderá por tipo de servicio a las categorías establecidas en el Reglamento aprobado por el Decreto Supremo N° 212, de 1992, del Ministerio de Transportes y Telecomunicaciones, o el que lo reemplace.
- d) Deberá mantenerse prestando servicios de transporte público de pasajeros por, al menos, 48 meses contados desde el otorgamiento del beneficio. El incumplimiento de esta exigencia, salvo en los supuestos de fuerza mayor o caso fortuito, obligará al beneficiario a restituir la suma percibida, reajustada de conformidad a la variación que experimente el Índice de Precios al Consumidor determinado por el Instituto Nacional de Estadísticas o la entidad que lo reemplace, entre el mes anterior a aquél en que se percibió y el que antecede a su restitución. La devolución deberá materializarse dentro de un plazo de sesenta días hábiles contado desde que haya quedado establecido el precitado incumplimiento por la Subsecretaría de Transportes.
